

# PRIVACY POLICY

This privacy policy governs your use of the software application TecGPS (“Application”) for mobile devices that was created by TecGPS Sistemas de Rastreamento Ltda. The Application is a mobile GPS tracking platform, which allows the user to visualize in real time the position and other information from its GPS tracker(s).

## **User Provided Information**

The Application obtains the information you provide when you download and login to Application. However, please keep in mind that information have been already provided at the moment that you have purchased your GPS Tracker in our website, online. No extra information are pulled by Application rather than those already provided before in our online store.

We may also use the information you provided us to contact your from time to time to provide you with important information, required notices and marketing promotions.

## **Automatically Collected Information**

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browsers you use, and information about the way you use the Application.

## **Does the Application collect precise real time location information of the device?**

When you visit the mobile application, we may use GPS technology (or other similar technology) to determine your current location in order to determine your position in relation to your GPS trackers position. This information has a limited use inside the Application to calculate distances. No positioning information will be ever sent to our servers, therefore will be kept only within your mobile phone or tablet. No sharing of your current location will ever be shared with other users or partners.

## **Do third parties see and/or have access to information obtained by the Application?**

No. We will never share your information with third parties. All collected information is only and limitedly used for in-Application operational purposes.

## **What are my opt-out rights?**

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network. ## **Data Retention Policy, Managing Your Information**

We will retain user provided data for as long as you use the Application. The Application will not retain any data longer than the moment the Application have been uninstalled.

## **Children**

We do not use the Application to knowingly solicit data from or market to children under the age of 13. We will delete such information from our files within 72 hours.

## **Security**

We are concerned about safeguarding the confidentiality of your information. We provide physical, electronic, and procedural safeguards to protect information we process and maintain. For example, we limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Application. Please be aware that, although we endeavor provide reasonable security for information we process and maintain, no security system can prevent all potential security breaches.

## **Changes**

This Privacy Policy may be updated from time to time for any reason. We will notify you of any changes to our Privacy Policy by posting the new Privacy Policy here and informing you via email or text message. You are advised to consult this Privacy Policy regularly for any changes, as continued use is deemed approval of all changes.

## **Your Consent**

By using the Application, you are consenting to our processing of your information as set forth in this Privacy Policy now and as amended by us. "Processing," means using cookies on a hand held device or using or touching information in any way, including collecting, storing, using and deleting information, all of which activities will take place in Brazil. If you reside outside Brazil your information will be transferred, processed and stored there under Brazilian privacy standards.
